Regulations for Use of Unfair Means</p> <p>(i) "Any candidate who, after announcement made by Superintendent, fails to part with or is found to have in his/her possession or access, books or notes, papers, bags, pencil cases, pagers, mobile phones, calculators, palmtop computers, tape recorders or any other material or equipment in his/her possession <u>relating to the subject of examination of that paper</u> or detected in giving or receiving assistance, <u>or using or attempting to use any other unfair means in connection with the examination</u>, shall be expelled by the Superintendent from the Examination Centre and his/her answer book shall be cancelled <u>and case be reported to the Controller of Examinations</u>"</p> | <p>8. Regulations for Use of Unfair Means</p> <p>(i) "Any candidate who, after announcement made by the Superintendent, fails to part with or is found to have in his/her possession or access, books or notes, papers, bags, pencil cases, pagers, mobile phones, <u>smart watches</u>, calculators, palmtop computers, tape recorders or any other material or <u>electronic</u> equipment in his/her possession, <u>regardless it is switched off or otherwise</u> or detected in giving or receiving assistance <u>in this connection to any other student during examination</u>, shall be expelled by the Superintendent from the Examination Centre and his/her answer book shall be cancelled <u>immediately</u></p> <p><u>Relevant material, electronic gadget or equipment shall be confiscated permanently by the university. Further, he/she may be disqualified from appearing in the next examinations for a period of one year and the remaining attempts within this duration</u></p> |

shall be counted towards the total number of attempts allowed by the University."
